The Finance Team of the Penn Yan United Methodist Church is excited to introduce you to a new way to present your offerings on a regular basis. It's called "**e-giving**", which simply means your offering is made in the form of an automatic withdrawal from your bank account, regardless of which bank you use.



You simply let us know the amount you would like deducted and when you would like the deduction made, sign the attached form and give us a **voided** check or savings account withdrawal slip and we take care of the rest! You don't need a computer and there is no cost to you (or the church) for this service.

We live in a technological society which gives us opportunity for many conveniences like never before. With more and more people shunning traditional checks and carrying less cash in their wallets, **e-giving** is a great option.

## Why use e-giving?

### e-giving is simple:

- Each offering using a paper check requires you to write the check
- You never have to worry about missing or forgetting your offering
- **e-giving** is automatic; perfect if you are unable to attend worship or go away on vacation

### e-giving is safe:

- Each payment is deducted from your account on the date you decide so it's easy to track. In contrast, you never know when checks will be deducted from your account.
- Your bank protects your personal account information. You actually gain financial privacy with **e-giving**, because checks pass through so many hands.
- Your checks contain a great deal of information; information you may not want to give out.

### e-giving is smart:

- **e-giving** saves you time
- **e-giving** eliminates the cost of a check
- **e-giving** cuts down on the administrative process of handling, receiving, counting and depositing funds
